Fire Safe Council Receives Grant!



That means that there will be funds available starting in the fall for fire mediation on a co-pay basis. Groundwater on the Mountain by Rob Hawk

Water on Palomar is our most important resource. Unlike the City, where water is brought in from rivers hundreds of miles away, Palomar's water comes from underground storage of rainwater. Rain falling in the forest percolates through the soil to natural underground reservoirs in cracks and crevices in the rock, called aquifers. Wells drilled deep below the water table pump out this water for our use, like many straws drinking from the same cup. The amount of water in the cup is controlled by the amount of rain- and snowfall (precipitation) we get every year, and the amount of water we pump from wells, or that flows off the mountain to the sea. While this is an oversimplification of a complex system, the point is that if people use more than is recharged from rain, the water levels drop and wells and springs go dry.



Wells provide the only water for people's homes, agriculture and fire-fighting. Lack of water during the recent drought has already killed or weakened many trees in the Cleveland National Forest and elsewhere on Palomar Mountain, causing an exceptionally high risk for wildfire. In order to help understand the complexity of the groundwater system that everyone on the mountain shares, the PMPO is collecting well water level data from anyone with a well that is willing to provide it. This data will be matched with rainfall data to try to understand the sensitivity of the system to drought conditions, and to evaluate impacts by new projects relying on groundwater that may impact the community water supply.

The La Jolla Tribe has recognized the concerns of their mountain neighbors and is working with the PMPO and adjacent land owners in developing their new commercial well on East Grade Road. Preparations are underway for a full-scale pumping test in the next few months to determine potential safe yields from their commercial well project approved by the Bureau of Land Management in 2005. The Tribe's professional staff will be instrumenting wells adjacent to the test well to determine the area affected by the test, and provide a basis for design of the permanent production well. The Tribe and their staff have committed to working with Palomar residents in protecting the Mountain groundwater resources from detrimental effects from their pumping.

In order to have a clear understanding of those effects, we are requesting that anyone who has a well provide monthly or weekly level measurements to the PMPO contact person Rob Hawk (at PO Box 157 by mail on the Mountain, tecdelver@ att.net or 619-287-4992). We would also like to get a GPS location of your well from you, or someone on our committee can measure it when we take the water measurements.

The PMPO is funding the Water Company employee to measure wells on a monthly or bi-monthly schedule. If you would like to volunteer your well to be measured, please fill out and sign the attached permission form and mail it to the PMPO. Please include a map showing the location of your well. If you have any questions, please call Rob Hawk or any PMPO Board member.

Report from the Palomar Mountain Volunteer Fire Department

It's been a busy year at the Palomar Mountain Volunteer Fire Department. Progress is being made towards the completion of the first phase of converting the original house into the Palomar Mountain Community Center. Thanks to the hard work by Earl Walls, Bruce Graves, Pete Weisel, Doug Lande, Jerry Johnson, Tom Fortney, and many others the community will soon have a dedicated place for meetings and special events. Plans are in the works for an addition to enlarge the Community Center and we hope to eventually get the old well up and running and install backup generators for all the buildings.

Grant funds and donations have made it possible for the fire department to add an administration and firefighter sleeping quarters. Once the portable office trailers, currently stored at the helicopter landing pad are in place, the work will begin on interior modifications for bunking firefighters including restrooms, ready room, office, and kitchen facilities. Thanks to our Community Emergency Response Team (CERT) and the Palomar Radio Club, the current office inside the fire station is being upgraded to a sophisticated communications room. In addition to the dispatch center in El Cajon, we will soon have the capability, in an emergency, to communicate via radio with the Observatory, the School Camp, the Palomar Christian Conference Center, and all ham channels.

Monday nights are training nights at your fire department. We have just completed vehicle extrication classes and are currently conducting our annual wildland fire exercises. An important addition to our training has been the participation of the La Jolla Reservation Fire and CALFIRE Station 70. We work side by side with CALFIRE and La Jolla Reservation on numerous calls every year. Training together allows all of us to increase our proficiency and form important bonds between the crews.

Currently the fire department has 28 members, including 13 Emergency Medical Technicians. Each member brings their own unique background and work experience. Several of our members are employed by the U.S. Forest Service. Several others are employed by the Observatory, various ambulance services, and the State Park. Some of our members live off-mountain and drive up for training and station staffing. It's very rewarding to volunteer your time to your community and we are always on the lookout for new members. If you are interested in joining the department please contact the fire station at (760) 742-3701.

Finally, May 28th marks the 15th anniversary of the dedication of the Firehouse and mortgage payoff. All equipment, land, buildings, and fire engines are owned outright by the department. That's pretty unique compared to other volunteer fire departments in San Diego County. We are grateful to the former and current community members who worked so hard to form, organize, and run the Palomar Mountain Volunteer Fire Department starting way back in 1975. The members of the Palomar Mountain Volunteer Fire Department intend to carry on that dedicated tradition, at the same time providing the community with the best emergency services possible.

An Update from the Palomar Observatory

It has been another busy year at Palomar Observatory. Astronomical research is continuing and visitors are flocking to the observatory in record numbers.

Our people counter in the stairway in the Hale Telescope's dome recorded its highest number ever--118,248. Compare that count to the 44,733 people that were recorded in 2003. In just the last half of 2008 the observatory recorded visitors from all 50 states, including Washington, D.C., Puerto Rico, and Guam. Our international visitors came



from 56 countries and all continents, except Antarctica.

Increasing numbers of visitors have been good news and bad news. The good news is that we have more people than ever interested in astronomy and the observatory. The bad news is that with our increasing numbers of visitors, particularly those that come for snow play, come complications and potential problems.

Astronomical research continues to advance 2008 saw the introduction of a new camera for the 200-inch Hale Telescope designed to find planets that orbit other stars and a new 100-megapixel camera for the 48-inch Samuel Oschin telescope. A new five-year observing program has just begun on the 48-inch telescope. Astronomers are very excited about this particular program. Look for it to grab some headlines soon. A new instrument, designed to probe the matter located between distant galaxies, will be installed on the 200-inch in early summer. This should give astronomers a look into the early universe and the nature of its unknown constituents: dark matter and dark energy.

In April 2009 over 100 astronomers from around the world gathered at Caltech in Pasadena to discuss the results of their research all of which was performed at Palomar Observatory.

The observatory would like to remind its mountain neighbors that their outdoor lights can have an adverse affect on our observations. Please turn off any unnecessary lights. Make sure that they are pointed downward and only use as much light as you really need.

County General Plan by Tom Burton

Your PMPO has been following the County's actions toward a new General Plan since its inception—over ten years ago.

The County has a preliminary draft that is in the Environmental Review phase. They will be making a presentation before the Planning Commission on May 8th, and give the Board of Supervisors a status report on May 13th. The PMPO has made a mantra of our three "C's" approach to how we believe the proposed plan should impact Palomar: restore our Commercial Property; allow Clustering—or greater densities around the Commercial properties; and recognize us as we are and have been since the late 1800's as a Country Town—thereby exempting us from the Forest Conservation Initiative (due to 'sunset' or expire at the end of 2010—just about when the new General Plan could come into being).

We are in good company with other 'back country' communities who have similar issues and concerns—and who are also largely ignored.

This year's major accomplishment was getting still another set of comments to the County on their Draft General Plan. The whole PMPO was involved. We reviewed all the past materials and this time supplied the County with a map. There were several full community meetings attended by County personnel. We heard what we wanted to hear from them—but it has yet to be written into the Draft Plan. Hence the call to vigilance, yet again!

Other similarly situated Communities feel our REAL impact will be turning out masses of articulately objecting folks at the public hearings. Stay tuned. The PMPO and the Palomar Mountain News will bring you advance warning of when these meetings will be. Without that outpouring of public support, our issues and concerns are likely to be ignored by the more vociferous large community and planning trendy concepts espoused by the County's staff.

PAC: YOUR Palomar Action Committee

PAC, now a subcommittee of the PMPO, meets about every other week to investigate and act upon issues of concern to the Palomar Mountain Community.

Originally formed with two PMVFD members, two CCPM members and one independent, the group is about five years old. During that time its initial focus of facilitating the Community Center, bore fruit. Countless person-days of work yielded untold tens of thousands of dollars of benefit for the PMVFD and CCPM as it solicited and realized donations of cash, real and personal property. The group was responsible for the elimination of a cloud on the title to the PMVFD property, procured a free survey of the PMVFD site and days of valuable professional expertise in building design, law, tax and real property areas toward the improvement of the PMVFD properties and the manifestation of a more functional, and now nearly completed Community Center.

Last year the PAC was 'adopted' by the PMPO so that it could supplement its quarterly meeting schedule with a subset of its members; Earl Walls, Bruce Graves and Bonnie Phelps, joined by 'independents:' Jerry Fisher and Tom Burton.

The PAC task list has over fifty completed projects or investigations.

Currently on its 'plate' are: working to resolve the Dual Survey problem; tracking the County's General Plan Amendment; exploring alternatives to the proposed SDGE power outage in times of high fire risk; investigating the proposal for a Pala race track; the Palomar Easement Project; collecting information on the Poomacha fire; and Volunteer Fire Watch program institution.

The PAC is PMPO's way to be more available and responsive to the needs of the Community.

The Community Safety Center by Earl Walls

Thanks to limited number of great volunteers, many of whom are mountain construction professionals, we have made fairly significant strides towards completing the remodel of the house at the fire station towards its use as a Community Center. The inside will hopefully be complete within the next several months, which by that time will have weather that will permit us to complete the work on the outside. For all who have participated, a great big thank you.

Our hopes for securing a grant to add the addition to the west side of the house were dashed when the County advised us that there were insufficient funds available to even consider starting the project. Our goal was for \$200,000. We were advised that we might get as much as \$38,000. Consequently, I worked with Captain Cliff Kellogg, of the PMVFD, in the revision of the grant request to provide funding for the addition of emergency generators for each of the houses, the apparatus building, and the soon to be located administration/dorm building (the gifted modular buildings on the heli-pad); and the activation of the old well on the fire station site.

To be honest, I have been somewhat disappointed in the general response of the community in the participation of the remodel effort. Had it not been for the pros and some off mountain volunteers we would not be anywhere near completion of the inside, let alone any progress on the outside. I realize that most of the community has limited construction expertise, but there were a lot of things the inexperienced could have done. But, with only a few exceptions, the offer was not forthcoming. There is still work to be done to make the site one we can be proud of. I hope that what has been accomplished will instill in the community in general an attitude of wanting to contribute.



Traffic Safety Update

Motorcycle and Vehicle Safety

Motorcycle and vehicle safety issues on the South and East Grade roads are of major concern to residents and visitors to Palomar Mountain. Palomar Mountain Volunteer Fire Department spends countless hours and dollars attending to avoidable accidents on the South and East Grade roads. The CHP has been approached on several occasions in the past 6 years. It has been determined that the CHP is unable to address the issue and has informed the PMPO that there is a shortage of manpower and funds to accommodate effective patrols.

At the request of the US Marine Corps, when a Marine is involved in an accident they would like to be informed. The reason for this is that the USMC has a requirement that all troops wear a colored safety vest both on and off base when riding a motorcycle. The PMVFD has a form to report these incidents to the USMC.

There has been a noticeable increase in night time auto racing on the South and East Grade Roads.

PMVFD CERT Hosts a County-wide Exercise During AMGEN Tour of California Bike Race by Bill Leininger

On 22 February 2009, the AMGEN Tour of California Bike Race, featuring over 70 professional cyclists including Lance Armstrong, held its final leg in San Diego County. The highlight of this leg included a 4000 ft ascent to the summit of Palomar Mountain, and created an ideal opportunity for a countywide CERT exercise. Hosted by the Palomar Mountain Volunteer Fire Dept (PMVFD) CERT, the exercise focused on developing both Incident Command System (ICS) and Communication skills.

Palomar Mountain, in northern San Diego County, rises to 6,140 ft in elevation, and has only 2 paved roads of access. It is home to a state park, campgrounds, and the world famous Palomar Observatory of the California Institute of Technology. The southern face burned completely during the



Poomacha Fire in October 2007. On race day, snow persisted to the 4500 ft level. And, the mountain community of about 200 residents expected

as many as 5000 visitors to crowd the course, with no motorized traffic permitted on the roads while the race came through the 29 mile section around the mountain.

In planning support for the PMVFD during the exercise and race, the Fire Chief needed CERT to be its "eyes and ears". So, for the Communication portion of the exercise, the course was divided into sections to be covered by groups of 4-6 participants. Depending of the section size, topography, and crowds, volunteers patrolled on foot, bicycle, or car. All groups used HAM and FRS radios for communication, and would regularly report in on crowd and traffic conditions, race progress, and any notable events, using selected radio bands.

For ICS practice, CERT and HAM volunteers were co-located with the PM-VFD Incident Command Center, on the mountain summit. In addition to Fire Dept. resources, California Highway Patrol, EMS, and a Life Flight helicopter were also positioned here. The HAM's maintained communication with all the teams across the exercise area. Wall maps of the area (invaluable!) were posted, with identification of the sub-sections and team locations, call boxes, mile markers, and other references. Logistics activities for team resupply and a lunch run were sched-

uled and announced. Concurrently, the Fire Dept. was able to use the CERT communication network to maintain awareness of conditions over the entire course.

At the conclusion of the 10 hour exercise, all the volunteers felt much more comfortable with their radio skills, and how they fit into the ICS. Concurrently, professionals in the fire dept and law enforcement learned about the resources that CERT's bring to an event. In planning for the exercise, use of self-created Google websites (http://sites.google.com/site/pmvfdcert/Home) were immensely convenient in coordinating volunteers from multiple groups across the county, and then posting photos and collecting post-exercise feedback.
