

## BOUCHER HILL LOOKOUT UPDATE

This statement from the National Interagency Fire Center shouldn't surprise us here on Palomar, but it should concern us. My recent conversations with fire managers point to a fire danger potential worse than last year, and Cal Fire has already implemented a no-burn policy in State

Responsibility areas of the county. Even though Southern California dodged a bullet last season, we saw what could happen with the fires of May 13 - 15. All of this reinforces how careful we need to be in such a high-risk area as Palomar Mountain.

On the bright side, both fire towers, Boucher Hill and High Point, will be fully staffed for the fire season beginning April 19. The Forest Fire Lookout Association, San Diego Chapter, has accepted 35 new volunteer lookouts and is in the process of training them to assist the core of 85 veteran lookouts (including several Palomar residents) who keep watch over the mountain and surrounding areas. It is our plan this year to have two lookouts in Boucher



every day so that the high volume of visitors (nearly 9000 last year) does not interfere with smoke detection.

Last year from Boucher our lookouts called in 35 smoke reports and 55 lightning strikes. (We believe we were the "first report" on several of the May fires.) High Point logged 55 downstrikes and 22 smoke reports, one of which was a lightning fire near Bergman's not reported by anyone else. We encourage all PMPO members to stop by Boucher Hill tower, have a chat with the lookout on duty and pick up a souvenir t-shirt or coffee cup to help support our efforts to keep the mountain safe. #### THREE REASONS FOR TREE THINNING

Palomar is sure losing a lot of trees again with the drought. When you see the very top of some of these firs die, sometimes it can take years to claim the rest of the tree. Personally, we are also thinning out trees, especially ones that are closest to our well. Hopefully by thinning some trees, the ones that remain will survive the drought, and be kinder to our water table. Need another reason for thinning out your trees? Insurance. One of the most recent closings had their insurance company call after an inspector had been there. They were required to remove trees so that no tree branches hung over the roof. This is a new requirement for some insurance companies. The locals who do tree work are on the Yellow Pages, too, and I'm always glad to get your questions answered.

### TRASH REMOVAL

As most of you know we no longer have a dump transfer station up here. There are several neighbors who have a dumpster on their property and offer to share the dumpster. Depending on how many people go in on it, the monthly fee is very reasonable. Simply visit www.palomarmountainnews.com and click on the Search button. Search 'Dumpster' and the most recent option will pop up for you. The Pala Transfer Station, just this side of the Pala Casino is the closest dump and absolutely the best price. They take anything and everything and are a pleasure to deal with.

## **USEFUL STUFF TO GO AWAY?**

With my Real Estate business, I often help orchestrate a lot of cleanup for property owners, prior to putting their property on the market. Sometimes it is contagious and often the neighbors get in on the act. I thought perhaps this info might be appreciated by some of you who aren't interested in selling, but have some things that are no longer needed and taking up space. The Christian Conference Center can usually use your working washer, dryer, and refrigerator as a donation. Sometimes they have a use for gently used furniture and will pick up at your property and provide a tax deductible receipt. We have the 'Gleaner Girls' who will pick up useful, shabby chic, furniture, weathered, rusty, kitchen or garage/outdoor items and more at no charge. Have an old vehicle or trailer? Those can go away, too. Also, there are several options for hauling and property cleanup. Just let me know and I'm glad to point you in the right direction to get your job done.

### PHONE SERVICE

Cell phones don't work at most properties so it is wise to have one of those old fashioned phones plugged in to an outlet. I use AT&T because they offer "The Message Center". That works great for me when I'm heading off the mountain and forward my calls to

my cell (since my cell doesn't work up here). That package also offers Caller ID, 3 way calling and other features that you might appreciate. However, some folks have enjoyed cutting their phone bill by having a Magic Jack phone for much less. That service is much improved. You do need to have internet and you're all set.

#### **INTERNET**

New Internet options! You have several internet choices on Palomar. The service with the fastest internet that I have found is through Western Broadband. Fred and Wally have worked real hard to set up repeaters in different areas to be able to provide service where it wasn't available in the past. Thanks for all their hard work. ## REAL ESTATE UPDATE

Landlocked Property, Lack of Road Maintenance Agreements and Lender Requirements – Unless your property fronts on a county maintained road, most properties on Palomar show up on a title search as 'Landlocked'. This means they do not have a recorded, deeded easement from the property to a public maintained road. (There are a few exceptions). Depending on the area, maybe a road is plotted to a public maintained road, but that plotting is generally not insured by the title company. Some title reports do show physical access.

In the past, with a larger down, a lender would loan on these properties. However, lender rules have changed.

To get a conventional loan now, most lenders are requiring:

- a. A plotted easement to a public maintained road and
- b. A road maintenance agreement between the neighbors that share the road

Depending on the lenders, it can be hard to sell your property since most properties now on Palomar would need a cash buyer, or the seller to carry the loan. This is because most property does not have a plotted easement to a public maintained road or a road maintenance agreement.

Over the past few months, three vintage maps have been located that were recorded decades ago. These maps allow title companies to plot roads from the property to the county maintained road. However title companies are not able to insure those roads and there are few known road maintenance agreements.

In the future it would be wonderful if this easement and road maintenance situation could be resolved. Easements and road maintenance agreements can be very complicated and expensive. You are welcome to contact me to check on the status of your property.

## GEORGE DOANE BIOGRAPHY UPDATE

The 'George Edwin Doane of Palomar Mountain' biography that I first published online in January 2014, via my Palomar Mountain History website (accessed via URL above), is in its eleventh revision since first publication. New information on Doane includes his death and burial, excerpts from his writings, and details on his Palomar and New Mexico lands. The content of revisions is noted in the preface to facilitate locating newer information in the Doane biography.

## APPLE VARIETIES ON PALOMAR MOUNTAIN

An inquiry about apple varieties grown historically on Palomar Mountain led to this compilation from newspaper articles and other resources:

## **UPCOMING**

A biography of Clark Cleaver, the Apple King of Palomar Mountain, who passed away in 1912, is nearing completion, and will be published on my Palomar Mountain History website (URL above). Cleaver had an interesting life; various Palomar Mountain sources note he didn't talk much about himself or his past, so researching his life took some digging. Clark Cleaver came west to California in the Gold Rush migration, was involved in an early California Indian War, did extensive gold prospecting in the Sierras, was a homesteader in Nevada, and then finally moved to Palomar Mountain in 1888-1889, beginning on the property on the south side of what is now State Park Road, across from Bailey Meadow Road. Clark Cleaver was a prominent Palomar Mountain resident, a Palomar Mountain school trustee, an apple orchardist and a booster for Palomar Mountain agriculture in the San Diego area, and the contractor for the South Grade road built in the 1890s.

## COMMUNITY CENTER OF PALOMAR MOUNTAIN

## **Background Information**

We are still hoping to find a way to build a real community center for Palomar Mountain.

In 2007, the Palomar Mountain Volunteer Fire Department received a \$50,000 grant to repair the old house next to the fire station for use as a community center and to install two prefab buildings behind the fire station to serve as a fire department training room and an overnight crew bunkhouse.

Earl Walls led 15 community volunteers in fixing up the old house with a new kitchen, bathrooms, and drywall, finishing in 2011. Unfortunately, right afterwards the county told us that our on-duty firefighters were no longer allowed to stay in the prefab buildings behind the fire station, so they had to move into the house.

This means we cannot use the house for community meetings. We are in limbo until a new fire station is built (someday) and we get the house back, or perhaps we get a shared training & meeting room in some future bigger fire station.

# SEARCHING THE SKY FOR DANGEROUS NEIGHBORS

Last year, Palomar Observatory dedicated its new exhibit titled Searching the Sky for Dangerous Neighbors at the Addison White Greenway, Jr. Visitor Center.

The exhibit focuses on the work of Dr. Eleanor Francis "Glo" Helin (1932 – 2009), a leader in the detection and study of Near Earth Objects (NEOs) and a prolific observer at Palomar Observatory.

Palomar's first research telescope, the venerable 18inch (0.46m) Schmidt, serves as centerpiece of the new exhibit along with topical panels, videos, and artifacts that describe the important work of identifying potentially hazardous NEOs and Helin's significant contributions to that work.

The exhibit was dedicated on 12 June 2014 in a delightful event that celebrated Helin's life, work, and scientific legacy. In attendance were

the Helin family, as well as some of her former colleagues and collaborators, the Chair of the PMA division at Caltech, Caltech employees, and Observatory staff and docents.

Keynote presentations were given by Drs. Amy Mainzer (JPL) and Rebecca Oppenheimer (AMNH).

#### Eleanor "Glo" Helin

Eleanor Helin was a planetary scientist at the California Institute of Technology (Caltech) and the Jet Propulsion Laboratory (JPL). She was a pioneer in the search and survey of near Earth asteroids (NEAs)—asteroids that occasionally come close to Earth and can become a potential impact hazard.

Helin began her hunt for asteroids in 1972 at Palomar Observatory using the 18inch Schmidt telescope. She had joined Caltech in 1960 as a geologist interested in meteorites and the impact origin of lunar craters. Over time, her interest shifted to studying potential impactors in Earth's vicinity. Her work with the Palomar Planet Crossing Asteroid Survey(PCAS) photographic

program yielded its first near Earth asteroid on 3 July 1973.

By the end of the program in 1995, PCAS had discovered 65 NEAs, about a fifth of all NEAs known until then.


technology As the became available, Helin pressed for automating the search for NEAs. This was accomplished with the Near Earth Asteroid Tracking (NEAT) project. NEAT began operations in 1996 at Haleakal'Observatory in Maui, Hawaii, and at Palomar in 2001 with the Samuel Oschin 48inch Telescope. In eleven years of observations, NEAT found over 36,000 new Solar System bodies of which 442 are near Earth asteroids

Helin was awarded many honors, including NASA's Exceptional Service Medal and the naming of the minor planet (3267) Glo. The USS Helin (NCC1692), a starship in the Star Trek franchise, was named after her for "having discovered an unprecedented number of asteroids and comets." Indeed, the Minor Planet Center lists Helin among the top discoverers with

over 500 asteroids and a dozen comets discovered or codiscovered.

The recognition she appreciated most was an honorary doctorate in 1992 from her alma mater, Occidental Collegein Los Angeles.

### The 18-inch Schmidt Telescope

The 18inch telescope was the first instrument at Palomar Observatory. It saw first light on 5 September 1936 and was Palomar's only operational telescope until 1949. Beginning in the late 1940s, this instrument was used in conjunction with the newly built 48-inch Schmidt (later to become the Samuel Oschin Telescope) to provide targets for the 200-inch Hale Telescope. Later, between the 1970s and 90s, the 18-inch proved to be a workhorse in the systematic search for minor bodies in the Solar System. In its long and productive life, this instrument has yielded many discoveries, including a large number of asteroids and nearly 50 comets.

Searching the Sky for Dangerous Neighbors was made possible thanks to a generous gift from the trust of Eleanor Helin and her husband Ronald. The restoration of the 18-inch telescope was carried out by members of the Palomar Observatory staff who brought the old instrument back to its former glory.

# FRIENDS OF PALOMAR MOUNTAIN STATE PARK ANNUAL REPORT

It's hard to believe, but it's been almost three years since Palomar Mountain State Park was supposed to be closed by the California Department of Parks and Recreation due to budget deficits. Not seasonally... but permanently. As in gated, shuttered, boarded up, and left vulnerable to vandals, squatters and poachers.

But through the generosity and hard work of a lot of people, Palomar made it through its darkest hour so that today, not only is the park still open, it's open full time and with full services. And even though you may not read or hear about it from the media, many California state parks are still sadly limping along. The entire Palomar Mountain State Park community of supporters should be proud of what they've accomplished!

To get to the heart of the matter, it comes down to money: Money to fulfill our contractual obligation to close the budget gap between the park's income and expenses. Money to pay for maintenance that's way overdue. Money for outreach programs to kids. Before Friends of Palomar Mountain State Park stepped into the picture, there just wasn't enough money to do these things... so the park went without for years. But things have changed!

As of the end of 2014, we'd raised over \$700,000 for the park. About half is in the form of "matching funds" provided by the State Parks department on behalf of Palomar. These funds were granted as a dollar-for-dollar match for contributions that we received and, in turn, donated to the department for the exclusive benefit of Palomar. This matching money tends to be used for all or part of major and pretty much unseen infrastructure improvements, such as a booster pump to get water up to the Boucher summit, or moving the well in Upper Doane valley to comply with county health requirements.

The other half of the money we've raised has come from a variety of donors – individuals, corporations and foundations – all of whom share an affection for our park. They can take pride in the many other – and more visible – things that the park has finally been able to do after years of neglect, such as some of the projects accomplished in 2014: improve the two campground bathrooms with new roofs and doors after 30 years of deterioration, replace the damaged and missing posts on Doane Valley Nature Trail for the trail's self-guided tour, and giving the buildings throughout the park a complete facelift (and renewed protection) with fresh paint and stain.

And as important, with these contributions, the park can now afford additional park aides and offer educational and interpretive programs to children who can see the mountain from where they live but have never been here... and could never visit the park were it not for the money Friends of Palomar provides for school bus transportation and interpretive guides. These are kids who say, "I've never been to a place like this.. I've never seen a deer or touched a fox pelt or sat by a campfire... I need to bring my family here!"

None of this would be possible if the park's supporters didn't step forward and not only keep the park open, but pay for improved facilities and services and new programs.

But the park isn't the only one with a success story for 2014. Friends of Palomar Mountain State Park itself reached some important milestones. Starting out as a committee of our 501(c)(3) fiduciary sponsor (Cuyamaca Rancho State Park Interpretive Association), we always had a goal of becoming our own 501(c)(3) association. And that dream was realized in early 2014.

But there was still one more thing we had to achieve before we could break away from CRSPIA and take Palomar under our wing: become an official cooperating association recognized by the California Department of Parks & Recreation. This is a special designation that provides special privileges, but also carries especially high standards and obligations. I'm pleased to say that we reached this milestone earlier this year, and, as a result of achieving the status of cooperating association, we have received all the remaining funds we raised through CRSPIA for Palomar. We have left the nest and are in free flight!

The PMPO is part of our success story. The PMPO was a Charter Supporter way back in 2012 when we were just starting out as a tiny committee and before we even knew whether State Parks would agree to the deal we were offering to keep the park open. And I know you'd recognize the names of at least two of our original committee members –Michael Walsh and Rosemary Johnston. They are now vice-president and secretary, respectively, of this new, vibrant organization called Friends of Palomar Mountain State Park!

Please accept our thanks for supporting our cause from the very beginning and for continuing to be a loyal partner.

# PALOMAR MOUNTAIN VOLUNTEER FIRE DEPARTMENT REPORT





he PMVFD responded to 95 calls in 2014. We averaged 1.82 calls per week and responded to 26 motorcycle accidents, 34 medical aid calls, and 19 structure/vegetation fires, ringing alarms and smoke checks, along with public assist calls and traffic hazards. The busiest month in 2014 was August and our busiest day of the week was Saturday.

We currently have 34 members with thirty of them being EMT's. Most days we are staffing the station with at least four or five firefighters. We usually have five or six firefighters staffing the station on weekends, occasionally more. Thanks to the dedication of our volunteer reserve members we consistently have more staff on duty every day than any other station in the San Diego County Fire Authority.

Working with Cal Fire Battalion 7, the Palomar Mountain Fire Department has been awarded two grants through the Department of Forestry and Fire Protection. The funds were made available through the SRA Fire Prevention Fund. The purpose of all State Responsibility Area Fire Prevention Funds (SRAFPF) is to undertake fire prevention activities that address the risk and potential impact of wildfire to habitable structures in the SRA as worsened by drought conditions.

One grant is for the Palomar Divide SRA Fuel Break. Specifically this project intends to reduce risk and impacts from wildfire by reducing fuels, 75 feet from each side of an existing road system on the Palomar Divide, to create a 150-foot strategic fuel break approximately 2 miles long. This fuel break can help to contain a wildfire before it can enter the Palomar Mountain Community.

The other grant is for three separate Community Chipping days, where homeowners can have their tree and brush trimmings chipped up into mulch to be used or hauled away. The department will keep the community informed as the grant

process continues.

Finally, the creation of the San Diego County Fire Authority in 2008 has continued to bring about many changes to the volunteer departments. Change isn't easy and we've had to adapt, just like every other rural department. We all want to keep our fire department going strong for many years to come. An integral part of this is the fire board, elected by the community, to ensure that the decisions made are in the best interest of all of us here on Palomar Mountain. As your fire board continues to weigh the options and decide the best course of action they need your support and feedback. Please continue to support the Palomar Mountain Volunteer Fire Department.
