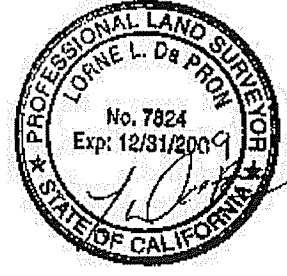

EASEMENT DESCRIPTION

THAT PORTION OF THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 15, TOWNSHIP 10 SOUTH, RANGE 1 EAST, SAN BERNARDINO BASE AND MERIDIAN, ACCORDING TO UNITED STATES GOVERNMENT SURVEY APPROVED APRIL 10, 1886. ALL OF WHICH FALLS WITHIN DOCUMENT 2007-0574048 RECORDED AUGUST 29, 2007 OF OFFICIAL RECORDS IN SAN DIEGO COUNTY RECORDERS OFFICE, SANDIEGO COUNTY, CALIFORNIA. THE EASEMENT IS FULLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHEAST CORNER OF SAID DOCUMENT 2007-0574048 BEING THE TRUE POINT OF BEGINNING; THENCE NORTH  $88^{\circ}49'20''$  WEST 330.00 FEET ALONG THE NORTHERLY LINE THEREOF TO THE NORTHWEST CORNER THEREOF; THENCE ALONG THE WESTERLY LINE THERE OF SOUTH  $01^{\circ}10'40''$  WEST 33.42 FEET TO THE NORTHERLY RIGHT OF WAY OF ROAD SURVEY 717; THENCE ALONG SAID NORTHERLY RIGHT OF WAY SOUTH  $86^{\circ}07'00''$  EAST 181.65 FEET TO THE BEGINNING OF A TANGENT CURVE CONCAVE SOUTHERLY, HAVING A RADIUS OF 240.00 FEET; THENCE EASTERLY ALONG SAID CURVE 78.92 FEET THROUGH A CENTRAL ANGLE OF  $18^{\circ}50'30''$  TO THE WESTERLY RIGHT OF WAY OF ROAD SURVEY 453-A SAID POINT ALSO BEING THE BEGINNING OF A NON-TANGENT CURVE CONCAVE NORTHWESTERLY, HAVING A RADIUS OF 130.00 FEET, A RADIAL BEARS SOUTH  $15^{\circ}11'37''$  EAST; THENCE NORTHEASTERLY ALONG SAID CURVE 91.01 FEET THROUGH A CENTRAL ANGLE OF  $40^{\circ}06'34''$  TO THE EASTERLY LINE OF SAID DOCUMENT 2007-0574048; THENCE ALONG SAID EASTERLY LINE NORTH  $01^{\circ}10'40''$  EAST 5.56 TO THE TRUE POINT OF BEGINNING.
