

COMMUNITY EMERGENCY RESPONSE TEAM (CERT)

The Community Emergency Response team (CERT) educates people about disaster preparedness for hazards that may impact their area and trains them in basic disaster response skills, such as fire safety, search and rescue, team organization, and disaster medical operations. Using the training learned, CERT members can assist others when professional responders are not immediately available to help.

People who go through CERT training have a better understanding of the potential threats to their home and community and can take the right steps to lessen the effects of hazards. If a disaster happens that overwhelms local response capability, CERT members can apply the training learned to give critical support to their family and neighbors. CERT training gives people the decision making, organizational and practical skills to offer immediate assistance.

Following a major disaster, first responders who provide fire and medical services will not be able to meet the demand for these services. Communication failures and road blocks will prevent people from accessing emergency services. People will have to rely on each other for help in order to meet their immediate lifesaving needs.

What can Palomar Mountain CERT do to prepare citizens for this eventuality?

• Present the facts about what to expect during a major disaster.

• Give the message about their responsibility for preparedness.

• Train them in needed lifesaving skills.

• Organize teams so that they are an extension of first responder services offering immediate help.

The CERT course will benefit any citizen who takes it, and they will be better prepared to respond to the aftermath of a disaster.

CERT is about readiness, people helping people, rescue, safety, and doing the greatest good for the greatest number. CERT is a positive and realistic approach to emergency and disaster situations where citizens can make a difference.

In additional to national CERT training standards, Palomar Mountain CERT members receive training in disasters that may impact our community, such as earthquake, wildfire and snow emergencies.

Palomar Mountain CERT members are trained to assist the fire department in public safety, radio communications, and first aid. Palomar Mountain CERT has their own fire engine and is trained to apply Barricade Gel to homes that are threatened by fire. Our 4 wheel drive Suburban can go where needed to assist our community.

A Basic Academy Training Course is being offered Friday-Sunday June 6-8, 2014.

This 9 unit (20 hour) course covers; *Disaster Preparedness Fire Safety Disaster Medical/Psychology Search & Rescue CERT Organization* The course finale is a realistic disaster simulation. For more information about this opportunity or to enroll in the June 6-8 class; contact CERT coordinator

BOUCHER HILL LOOKOUT UPDATE

s we are all aware, San Diego County is experiencing critical drought conditions. This poses a much higher-than-normal wildfire potential for our backcountry areas. Helping to keep watch over Palomar Mountain during these critical times are the two fire lookout towers, Boucher Hill and High Point, restored and staffed by the Forest Fire Lookout Association.

FFLA spring training for volunteer lookouts began the first Saturday in April. Applicants must attend two eighthour classroom sessions and two days of in-tower training including State Park orientation before they can serve as volunteers. This training is funded in part by a grant in aid from San Diego Gas and Electric.

The lookout towers will be opened for training purposes from April 20 through May 16 and will be in fullservice for the 2014 fire season on May 17. During the 2013 fire season High Point was staffed 100% of the time from May 11 through December 7. Due to the shortage of volunteers, Boucher Hill was only able to be open about 40% of these days.

This year fourteen new volunteers have applied to work at Boucher Hill along with an equal number of veteran lookouts who have now been accepted as State Park Volunteers. It is hoped that the lookout will be able to serve the public as a "fixed-point fire detection station" 100% of the time this season.

Any time that Boucher Hill is staffed, it is open to the public as an interpretive site and is an important drawing-card to Palomar Mountain State Park. On the days the lookout was open last season, over 3000 visitors climbed the stairs to enjoy the view and talk with the lookout/ docent volunteers. The volunteers are able to share with visitors the history of Boucher Hill lookout and Palomar Mountain, and educate them on the importance of wild-land fire safety.





BURN PERMITS

Folks with mountain property always seem to have downed branches especially after storms. Wondering what to do with all the trimmings after 'parking up' your property? Would you like to have a campfire or burn your cut brush? A permit is required. Permits are available only when the U. S. Forest Service deems it is safe. After a rain or snow is often a good option. Call the US Forest Service Lake Henshaw station (760) 782-3472, or Ramona office (760) 788-0250 to help keep our forest green and fire safe.

EXPLORE THE STARS

The Explore the Stars Program takes place one weekend a month, from April through October, at the Observatory Campground on Canfield Road, about half way down on the right. Amateur astronomers from San Diego, Riverside and Orange Counties bring out their own telescopes, sharing spectacular views of the night sky with all comers. DO YOU KNOW WHERE YOU LIVE?

Does the Fire Department know where you live? What is your easement number? What are your house numbers? Your neighbor may be a thousand numbers different than yours (mine is).

Each fire truck carries a cross reference book that has addresses and names to find your easement road. The Palomar Mountain Fire Department has a good system to find you, but it may need to be updated. PLEASE stop by the CERT booth at the PMPO Breakfast and check your information. Learn your easement number and make sure everyone in your household knows your address. Post your address on your house (3" numbers) and at your driveway to be located from the easement or street.

If you are unable to attend the PMPO Breakfast this year, please call Cliff at 760-742-3701 or Alan at 760-533-1268 to verify your information. Remember, this information is private and confidential, only for use by the Fire Department. This is a public service event from your local Community Emergency Response Team. (Easement numbers apply only to Crestline/Birch hill area)

TRAFFIC SAFETY

Palomar Mountain Traffic Safety organized an Inter -Agency Task Force this Fall for the Snow Emergency Plan. Palomar Mountain Fire Department, in past years, has not been able to respond as quickly during "Snow Days" because of gridlock on State Park Rd. and Canfield Rd.

New personnel at both CHP and Sheriff Department were briefed on the huge number of visitors Palomar Mountain has to deal with on "Snow Days". CHP early enforcement to keep the roads clear has worked well. Also the Forest Service has been a big help keeping the roads open. This year both CHP and Sheriff Department have public relations departments that will give public service announcements to the local radio and TV stations (including Spanish speaking) reminding listeners of the difficult and severe conditions on top. Using phrases like "Chains will be required", and "Expect long traffic delays" may discourage some from adding to the huge numbers on top. We are also trying to get an electronic sign down at the "Y" to let the visitors know about conditions at the Summit.

These ideas sure worked well this winter! Oh, wait, we never got any snow.

Report from the Palomar Mountain Volunteer Fire Department

The PMVFD responded to 99 calls in 2013. We averaged 1.90 calls per week and responded to 27 motorcycle accidents, 22 medical aid calls, and 20 structure/vegetation fires, ringing alarms and smoke checks, along with public assist calls and traffic hazards. The busiest month in 2013 was May and our busiest day of the week was Saturday.

We currently have 27 members with twenty one of them being EMT's. Most days we are staffing the station with two or three firefighters. We usually have three or four firefighters staffing the station on weekends. We have been actively recruiting new members by conducting interviews with recruits at the San Diego County Fire Authority offices. My goal is to build our roster to 45 members.

You may notice a Cal Fire engine parked at our station on Saturday mornings. The crew from Cal Fire Rincon (Station 70) comes up to train with us every week. Sometimes our station leads the training and other times Cal Fire leads. We have a great relationship with the Station 70 crew and our members enjoy the camaraderie and the increased level of training.

You may have heard that the Fire Department Board of Directors is currently investigating the option of signing a 50 year lease with the San Diego County Fire Authority. Like the other volunteer fire departments that have opted to sign a lease, our department would retain ownership of the property and would sub-lease back from the County. This arrangement would allow the Fire Authority to construct new station facilities without our community having to invest the time, energy, and money to achieve the goal of providing adequate housing for the duty crews. So far, De Luz Volunteer Fire Department and Montezuma Valley Volunteer Fire Department (Ranchita) have signed a lease resulting in new facilities amounting to \$815,000.00 and \$880,000.00 respectively. Ocotillo Wells, Shelter Valley, and Sunshine Summit are other stations that have had similar results. Your fire Board is carefully considering this option. The Board appreciates community feedback and invites everyone to attend Board meetings on the first Saturday of each month.

Don't forget to come out and say thank you to the men and women who make up your fire department on Awards Night. This year it will be held on Friday, August 29th, with a meet and greet beginning at 5:00 pm. Again, the family of Earl Walls will be carrying on his tradition of supplying the main course. Please bring a dish to share.

This year marks the 37th annual Fire Department Barbecue Fundraiser to be held on Saturday, August 30th, 2014. The Barbecue Committee has been burning the late-night oil figuring out what surprises are in store for us this year. From what I've overheard there are some interesting things in the works. Please mark your calendars and plan on coming out to support the department. Even if the department signs a 50 year lease with the county we still are responsible for operating and maintaining our station and equipment so every dollar earned helps to keep your fire department going. I hope to see everyone there.

Finally, the creation of the San Diego County Fire Authority in 2008 has brought about many changes that affect San Diego County volunteer fire departments in the back country. Change isn't easy and we've had to adapt, just like every other department. My goal, and the goal of the fire board, is to keep our volunteer fire department going strong for many years to come. An integral part of this is the fire board, elected by the community, to ensure that the decisions made are in the best interest of all of us here on Palomar Mountain. If you are interested in a board position please consider running for one of the three seats coming up this year. Nominations are closed 14 days prior to the annual meeting. Elections will be held at the annual board meeting Sunday, August 31st, 2014. Thank you for your support.

FRIENDS OF PALOMAR MOUNTAIN STATE PARK ANNUAL REPORT

Friends of Palomar Mountain State Park continue to push forward with a list of deferred maintenance projects at the park while strengthening the organization's infrastructure. After a very successful fundraising campaign that raised almost \$200,000, thanks to the generosity of our donors and the availability of an \$80,000 matching grant from the state's Department of Parks and Recreation, we are now at work collaborating with state park officials in the Colorado Desert region to prioritize utilization of these funds.

And we are encouraged and affirmed in our work by the park's citations for excellence from local, state, and national organizations. Recently, Sunset Magazine named the park one of the 44 best campgrounds in California and Hawaii. And the park became the only one in the county inducted into the Old-Growth Forest Network, a national organization which seeks to connect people with nature by identifying and helping to preserve the country's ancient forests. In addition, the San Diego Union Tribune named the state park one of the top 12 parks in the county.

Recently two members of the FPMSP board made a presentation to the Economic Development Committee of the North San Diego County Chamber of Commerce, pointing out that the park is an economic engine for North County communities as campers, hikers, and fishing aficionados stop for gas, food, and other commodities in nearby North County communities enroute to the park. We envision collaborating with Chamber members to promote and support the park in the future. During the Amgen bike race last May, we hosted an 'open house' at the park, offering free admission to bike fans assembled on the mountain to watch the cyclists as they raced up East Grade at a torrid pace, turned at the Fire Department site, and careened down South Grade. We also had a successful Apple Festival in October and are looking forward to hosting other special events during the year in cooperation with park staff.

In terms of infrastructure development, we continue to function under the auspices of Cuyamaca Rancho State Park Interpretive Association. However, we are moving towards becoming our own independent non-profit. Late last year we incorporated, and we await word that our 501c3 application with the federal government has been approved. We have developed and approved bylaws and are also developing a marketing program to expand awareness about the park and the work of FPMSP in order to boost visitation and revenue for the park.

John Muir once said, "Everybody needs beauty as well as bread, places to play in and pray in, where nature may heal and give strength to body and soul." Community center? What Community Center? Aren't the firefighters living in the community center building? Well, yes the community center house is currently occupied by the volunteer firefighters. The double wide trailer in the back of the fire department property is not suitable as a bunkhouse because it lacks toilets, showers, and running water. The community center house was the only option for housing the firefighters. Currently there are plans to build a new bunkhouse that is code compliant. If and when that happens, the Palomar Mountain residents will regain full use of the Community Center House.

Even so, we have been able to use the house for occasional events. On Christmas Eve the Community Center was utilized for a reading of lessons and carols. Cookies and snacks were served.
