to the efforts of Alan Serry and Burt Hulbert. On the subject of South Grade, have you noticed the new speed-limit signs. Again thanks to Alan and Burt for coordinating with the county and CHP.

Staffing of the fire station by the San Diego County Fire Authority continues to be exceptional. Thanks to Captain Dean Kowalski and all of the fire fighters who staff the station. Funding has been set aside for the construction of the new crew quarters and planning for the new building is under way. The PMPO also wishes to thank the Palomar Mountain Fire Department and CalFire for the use of their facilities as a venue for our various board activities as well as other community events.

The Fire Safe Council continues to support the community by sponsoring workshops and safety courses. Rainfall this Spring has been heavy, so serious commitments to fire prevention and brush clearing on our properties must remain a high priority. An important part of preparedness is the maintenance of our access roads. The Fire Safe Council is currently working with land owners and the PMFD to ascertain where work needs to be done. The

John Muir never visited Palomar Mountain State Park, but he may have penned these words if he had pondered the vista from Boucher Lookout and several other viewpoints in the park:

“When we contemplate the whole globe as one great dew drop striped and dotted with continents and islands flying through space with other stars all singing and shining together as one, the whole universe appears as an infinite storm of beauty.”

During the past year, Friends of Palomar Mountain State Park has continued to support the State Park by funding the seasonal park interpreter position and assisting with numerous deferred maintenance projects. We meet at least quarterly with state park supervisors to assess what needs to be done and identify opportunities to enhance the park's appearance and appeal.

We had a very successful Apple Festival in October with close to a thousand people in attendance. Recently, Eagle Scout Elliott Mollman rebuilt the steps leading to the flagpole near the park entrance. The road up to Boucher Lookout was resurfaced, and new interpretive signs installed near the lookout building. Will Meyst had a series of successful hikes and campfire talks, culminating with a presentation about raptors such as hawks, eagles, and falcons.

On April 13, the statewide “Park Champions” project recruited volunteers to create defensible space around Boucher Outlook and a ranger residence and to prune and mulch the historic apple orchard near the park entrance. The park's diverse array of plants, grasses, flowers, and trees thrums with new life after a bountiful rainy season. In the next year, we hope to make

progress on our vision to remodel the park residence near the campfire center, remove the cattails from around Doane Pond, and continue the refurbishment of the campfire center.

We continue to rely on the support of donors, visitors, and volunteers to achieve our purpose: supporting the park in its mission to enhance the public's experience through educational and interpretive programs and to preserve the park's unique biological, geological, archaeological, recreational, and scenic resources for the benefit and enjoyment of the public and to keep the park open with full services.

Great news as the speed limit signs are up on South Grade Road (30 MPH). East Grade will have 40 MPH. We are just waiting for the survey work on East Grade to be done by the county. The signs give the CHP officers a way to attack the racing that occurs primarily on weekends. Previously, the only tool allotted to the CHP was to write equipment violations such as for loud mufflers. Now they will be able to enforce speeding violations at more reasonable speeds. Previously the unposted limit was 55 MPH, even on turns and corners. CHP officers have stated that they will mostly be enforcing the speed limit on weekends as that is when most of the infractions occur.

This past February, CHP came up and helped with traffic during a snow event. They turned cars around with no chains or 4WD just after the 47.3 mile-marker. CHP Sergeant Maxon agreed in the future to stop cars at the base of the mountain at the stop sign intersection for road closures due to snow. This appears to be a better plan than causing a traffic jam near the top.



REPORT FROM THE PALOMAR MOUNTAIN FIRE DEPARTMENT BOARD OF DIRECTORS

The County of San Diego has completed the plans for the crew quarters to be constructed behind the fire station engine bay. Construction is slated to begin this summer. Also, widening and paving of the driveway around the building, enhancement of the handicap access to the community center, and a permanently installed generator to power all the buildings in an emergency will be included. Once the project is complete, the Palomar Mountain Community Center will be turned back over to the community and the firefighters will have new, modern living quarters.

In the last year a new tactical water tender was added to the station inventory. This 2000-gallon tender has a 750-gallon per minute pump and is capable of fighting both structure and vegetation fires. A brand new four-wheel drive Type 2 Plus fire engine

may be at the station by the time you read this. In addition, a Plymovent vehicle exhaust system was recently installed in the engine bay. This system automatically vents the vehicle exhaust to the outside and disconnects itself from the exhaust pipe when the fire engine goes out the door.

Our fire department is a "must cover" advanced life support station. This means that if our fire engine is called to assist in a structure or vegetation fire off mountain, a back up engine and crew must come up and cover the community. We always have at least one paramedic on duty. Palomar Mountain is also a training hub for the new county reserves so our community will often see two paid, full time career firefighters plus one or two reserves each day.

The Palomar Mountain fireboard continues to work with County Fire and CalFire. Senior station personnel attend every board meeting to keep

the department and the community up-to-date on what's going on with staffing, building plans, call volumes, and administrative issues. Palomar Mountain residents are always welcome to our board meetings, held on the first Saturday of the month at 9:00 am at the station. Attending board meetings is the best way to get accurate information on current happenings with the fire department. Get involved! There are two board positions opening up this fall.

Also, don't forget the fire department sponsors an active CERT organization currently under the leadership of Bill Leininger. Community members are welcome to apply for membership in CERT and learn valuable skills that could make a difference during a disaster. Last September's Star Party, "Four Bright Planets and the Moon", was a major success. It looked as though we had a much larger crowd at the Outreach Center that night than we've had for any other public star party in the last 10 years.

Palomar Science Meeting, July 2018

Last July, we held events here and in Pasadena to commemorate the 70th anniversary of the dedication of the Hale Telescope and to mark the beginning of science operations of the Zwicky Transient Facility (ZTF). On Sunday July 8, Caltech faculty members and others gave presentations at the Observatory in celebration of 70 years of scientific discovery. During the following three days on campus, researchers from Caltech and our partner institutions discussed the results they have obtained from their work here at Palomar. Three keynote lectures were given on Tuesday afternoon July 10 by author Ronald Florence (Creating The Perfect Machine), Robert Kirshner of the Moore Foundation (Accelerating Discovery) and Shri Kulkarni from Caltech (The Zwicky Transient Facility Dedication).

Hale Telescope Upgrades, November & December 2018

The Hale Telescope's 70 years of outstanding performance is attributable in large part to the meticulous maintenance given to it by the Observatory's staff. While maintenance operations are performed continuously, two major tasks are done at scheduled intervals: every two years, we put a new coating of reflective aluminum on the primary mirror; and, once every eight years, we remove the prime focus cage from the top of the telescope in order to service its mechanical parts, upgrade its electronics and re-aluminize

the secondary mirrors that are held there.

Beginning November 5, we took the telescope out of service for five weeks in order to do these two tasks in tandem.

During the first three weeks, the 26-ton prime focus assembly was lowered to the observing floor. Two of the secondary mirrors were removed and given fresh coatings of aluminum. The gearing and motors that control focusing and mirror placement were cleaned and tested. And all of the electrical connections were replaced in time for the entire assembly to be remounted on the telescope on November 27.

During the succeeding two weeks, the primary mirror was lowered from the telescope and moved to the aluminizing station. Its upper surface was cleaned in a day-long series of washings using acids and other chemicals to remove the old aluminum and other contaminants. The clean mirror was then put in the vacuum chamber. When a high vacuum was achieved, the staff fired the aluminum-laden tungsten coils that line the inside creating a plasma that put a thin coating of metallic aluminum on the mirror's surface.

Returned to service in mid-December, the telescope's operating condition is now better than when it was new and, with a mirror that reflects more than 90% of star light that reaches its surface, its performance exceeds the expectations of its designers.

ZTF Science Results

Using an advanced wide-field camera mounted on the Samuel Oschin Telescope, the Zwicky Transient Facility photographs the entire visible sky once every three nights. Each set of new images is digitally compared to previous images to look for objects in the sky that have changed position or brightness. More than 500,000 such changes or "alerts" are now being detected each evening and, while most are of no interest, news of each important find is automatically sent to astronomers around the world, often within 10 minutes of the discovery.

Objects that measurably change position from night to night are in all cases components of our Solar System. Since ZTF began operations in March 2018, we have found 50 near-Earth asteroids; one of which, designated 2018 CL, is seen as representing a possible impact hazard. Another discovery, 2019 AQ3, circles the Sun in just 165 days, the shortest "year" of any known asteroid. ZTF tracks brightness changes in the asteroids and comets it encounters, variations that reveal the rotational profiles and shapes of asteroids as well as the flaring behavior of comets orbiting beyond Jupiter.

Most celestial objects, however, are at great distances from the Sun and remain in fixed positions at least over short periods. Ranging from nearby stars within our galaxy to an array of exotic objects that existed in the early Universe, anything that changes in brightness, appears suddenly, or displays alterations in its spectrum transmits evidence to Earth about the physical processes driving such changes.



Supernovae, for example, arise without warning. The mechanisms that trigger certain types of supernovae events are poorly understood. Valuable information can, however, be derived by observing a supernova's rise from first appearance to maximum brightness. It is a short interval that commonly is missed in the absence of the type of monitoring performed by ZTF. On a 3-day cycle, the system images the sky repeatedly with the result that the ZTF camera has a good chance of detecting a supernova while its brightness is still increasing.

Since March 2018, ZTF has discovered 1,100 supernovae and on average two or three supernovae are being discovered every night in the skies over Palomar Mountain.

NEIGHBORHOOD WATCH

The Neighborhood Watch team held a community meeting in early April 2019. Representatives from CHP, CALFIRE and US Forest Service, the Sheriff's department, and Ranger Jessica Murany from the State Park, were all present to represent our respective law enforcement branches. We also had some great representation from our local mountain boards.

Sergeant Maxon and Officers Hollywood and Roberts were all in attendance from CHP. They gave us an update on the new speed limits on South Grade and East Grade. They explained that the new speed limits (30 MPH on South Grade and 40 MPH on East Grade) are intended to deter racing of motorcycles and cars. Officer Hollywood explained how a combination of speed studies and accident statistics were used to determine the safest speed limit for South and East Grades. Sergeant Maxon encouraged us all to adhere to the speed limit, but expressed that as long as we, local residents, were within reason, the new speed limit should benefit us from a safety perspective and apply mostly to visitors grossly abusing the speed limits.

The new speed limits are posted on South Grade. As of late April 2019 the plan is for CHP to have a stronger presence during the initial period of new speed limits. Sergeant Maxon did say that more often than not, they ticket drivers for equipment violations versus speeding violations, but both have the same effect, discouraging irresponsible riders and drivers from driving the mountain.

Sergeant Maxon let us know that an officer position (currently held by Officer Roberts) has been added to the Pauma Valley station, bringing the headcount there to four. Officer Roberts will be patrolling as much as he can in our area. And as always, the sergeant emphasized that we should always call in to report situations related to driving safety, racing, and speeding. Even if they can't get out to us right away, they can at least gather statistics about activity on the mountain. And if by chance there is a CHP officer nearby, he or she can intervene in a dangerous or unlawful situation.

Questions were asked about additional signage for speed limits on both Nate Harrison Grade and Crestline Road. Those questions should be directed to our Traffic Advisory Committee chair Burt Hulbert: curly.hulbert@yahoo.com. He can reach out to our county contacts with those questions.

The mountain has a new representative at the Sheriff's department. Our new Crime Prevention Specialist Leslie Carrillo introduced herself to the community and provided us with some stats on our reporting in the community. She also brought up some "602" trespassing forms. Leslie encouraged us all to call in to the Sheriff's department anything related to suspicious activity. She said that at the very least the data of our calls would be logged and she may be able to use that data to encourage more patrolling or other actions from the Sheriff's department. 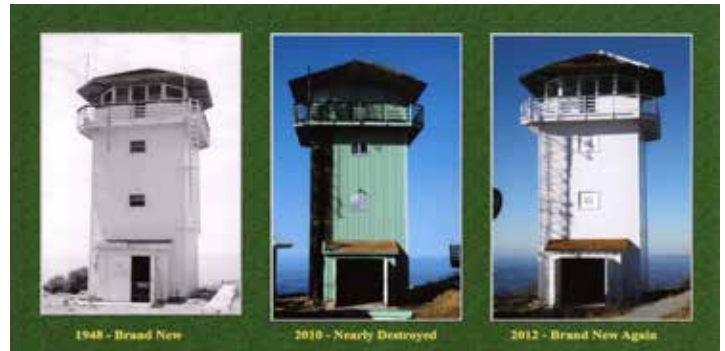
FOREST FIRE LOOKOUT ASSOCIATION

The Forest Fire Lookout Association (FFLA) is a non-profit organization that works hand in hand with State Parks, the Forest Service, CAL Fire, and several other entities to keep watch over our urban-wildland interfaces. Every year, prior to the fire season, FFLA members are required to recertify their training for fire shelters, a device that firefighters use as an absolute last resort in case they cannot escape a wildfire. This is a great chance for volunteers of the FFLA to meet their constituents at the Forest Service, CAL Fire, and State Parks. They are also filled in on key information about tower operations and any news that is pertinent to their duties. New volunteers are trained more extensively during the reconnect, getting extra information about wildfire science and having a chance to talk in depth with tower leaders and fire fighters about their duties.

The volunteers at FFLA are responsible for manning Boucher Tower and High Point Tower on Palomar Mountain during the fire-prone months of the year. They keep a watchful eye on northern San Diego County and a good portion of southern Riverside County. When California saw a dramatic increase in fire intensity in the early 2000's, firefighters and scientists concluded that the absolute best way to spot a fire early is to have human eyes constantly scanning for smoke plumes. Technology has made great strides in recent decades, but there is still no replacement for humans and their ability to spot smoke and identify it quickly as a potential wildfire. This is where the FFLA comes into play.

FFLA volunteers are not just lookouts, however. They also take on the duty of being a docent for the Historic Boucher Fire Tower. Lookouts invite members of the public up into the tower and show them the different instruments they use, discuss the history of the tower itself, and teach park-goers about wildfires and the importance of being prepared for the worst. On the whole, the FFLA provides State Parks consistent historical interpretation throughout the busy season while serving as vigilant watchers of San Diego County. Palomar Mountain State Park and all of State Parks are extremely grateful for their volunteership, and we encourage you to visit the tower someday and check out just how good the view is for yourself!

ACTIVITY UPDATE

Boucher Hill and High Point fire lookout towers had a relatively quiet 2018 fire season compared to the previous year, with the number of smoke reports and lightning reports down on the 2017 season (which is a good thing).

Collectively both towers reported:

- 94 smoke reports
- 32 lightning strike reports
- 11,678 people visited the towers (1067 for High Point and 10,611 for Boucher).

The towers were staffed for 221 days.

The 2019 season has already started with both fire towers opening on Sunday, April 21. Both towers will be staffed 7 days a week during daylight hours until early December. There are plenty of grasses around thanks to the rain but they are now drying out and already turning brown; an extremely dry fire season is predicted.

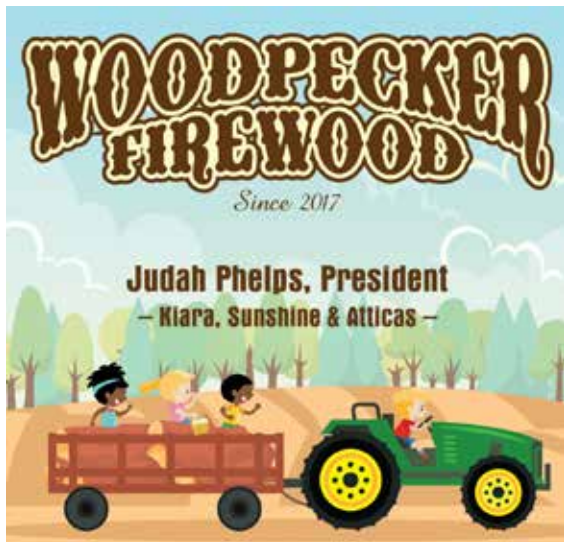

PALOMAR MOUNTAIN FIRE SAFE COUNCIL (PMFSC)

A 501c3, non-profit organization dedicated to helping keep Palomar Mountain fire safe

This has been an active year for the PMFSC. Our primary goal is to reduce wildfire risk on Palomar Mountain. Supported by a SDG&E community education grant and in collaboration with CERT and the USFS, we held interactive, hands-on workshops including Application of Barricade Fire Gel, Power Washer Training and Chainsaw Use, Maintenance & Safety. A Wildland-Urban Interface (WUI) workshop, sponsored by the FSC San Diego County, featured presentations by fire professionals about the critical importance of defensible space and how weather and topography determine fire behavior. Participants evaluated

local residents' defensible space first hand on an afternoon field trip. To increase defensible space and reduce residential fire hazards, we sponsored four Dumpster Days during the summer and fall of 2018. We were awarded a \$48,000 Neighborhood Reinvestment Program grant by the San Diego County Supervisors to fund 6 additional Dumpster Days and 6 chipping days in May-October 2019 and to purchase 72 Home Kits of Barricade Fire Gel for distribution at no cost to Palomar Mountain homeowners and residents. We continue to seek funding to improve an eastward evacuation route between Crestline Rd, Conifer Road and East grade (S7).

Things you can do now to safeguard your life and home:

Increase your defensible space:

Participate in upcoming PMFSC Dumpster Days and Chipping Days. Notifications posted on Next Door Neighbor and the Community Bulletin Board.

Register with Alert San Diego to receive San Diego County fire/emergency/disaster notifications on your cell phone, VoIP or email. <http://www.readysandiego.org/alertsandiego/>

- Install a **smoke/CO alarm** in your home. If disabled, infirm or over 62 years of age, the Red Cross will come to your home to install a free smoke/CO alarm.

- Install a Knox Home **Door Lock Box** to allow CAL FIRE access to your home in case of emergency. Installation is free if elderly or infirm. Contact Palomar Mountain CAL FIRE Station 79 for details.

- Replace older **structural vents** with new fire and ember resistant vents.
(e.g. Brandguard <https://www.brandguardvents.com>)

- Pick up a **free Barricade Fire Gel Home Kit**.
(Palomar residents only / maximum 2 kits per residence)
Contact Palomar Mountain CERT or Station 79.

- **Maintain your private road.** Keep 5' brush cleared on both sides to allow access for emergency vehicles
